ELIGIBILITY REQUIREMENTS

Who is eligible to participate in the Teammate Tuition Assistance Program?

To be eligible to participate in the Teammate Tuition Assistance Program, you must be a team member that has been employed full-time by Moore Holdings, LLC or one of its affiliates comprising all of the businesses that carry the "Renewal by Andersen" brand names including Garden State Custom Windows, LLC., Fairchester Custom Windows, LLC., Long Island Custom Windows, LLC., Atlanta Custom Windows, LLC., Toronto Custom Windows Corp, Windows, LLC., and Jemico, LLC and have attained a minimum of one (1) year of employment at the date of the application deadline (i.e. April 15, 2024).

Is the Teammate Tuition Assistance Program for full-time and part-time enrollment?

Yes! The Teammate Tuition Assistance Program | Moore Holdings is eligible for full-time team members who have attained a minimum of 1 year of employment who are enrolled or plan to enroll in full-time or half-time study (at least six credits or its equivalent) for the entire upcoming academic year.

Do I need to attend a certain school?

No particular school is required for this program. However, you must attend or plan to attend an accredited two- or four-year college, university, vocational-technical school, CEGEP Institution, or graduate school for the entire upcoming academic year.

Is there a minimum grade point average (GPA) that is required to receive the award?

Yes. The applicant must have a minimum grade point average of a 2.5 on a 4.0 scale (or its equivalent).

Are all areas of study eligible to receive an award through the Teammate Tuition Assistance Program?

No. Applicants must pursue or be in pursuit of a degree in Business or a related field that is related to the Renewal by Andersen | Moore Holdings, LLC business. Determinations on related fields of study will be made by Renewal by Andersen | Moore Holdings, LLC.

Can I get a certification?

Certifications through an accredited educational institution are eligible through the program. However, professional licenses are not eligible expenses.

SELECTION CRITERIA

How are recipients selected?

All eligible applicants who meet the eligibility criteria as described above will receive the award.

AWARDS

What is the annual award amount?

Tuition assistance of up to \$2,500 USD or CAD per student will be awarded per calendar year for full-time enrollment. Tuition assistance of up to \$1,250 USD or CAD will be awarded per calendar year for part-time enrollment.

Will payments be in USD or CAD?

The award payments will be issued in U.S. dollars (USD) to recipients attending college in the U.S. and Canadian dollars (CAD) to recipients attending college in Canada.

Does my award carry over from year to year?

No. Applicants may reapply to the program each year that they meet the stated eligibility requirements.

Is there a maximum lifetime award?

Yes. The maximum lifetime award for any eligible team member, including their dependents, is \$10,000 USD/CAD.

Is the award taxable income?

Yes. Tuition Assistance awards are considered taxable income.

Who are the awards paid to?

Award checks are made payable to the school and will be mailed to the student's home address in a Scholarship America envelope. The student must present the check to their school for endorsement and processing. It is considered fraud to deposit the check into your own bank account.

How are funds allocated?

Once the funds are paid to the institution where you have enrolled, they are divided evenly throughout the academic year. If you have any questions about how your school disburses scholarship funds, please contact the Bursar office at the institution where you are enrolled or plan to enroll.

When can I apply?

The 2024 application period will be open from **March 11, 2024 through April 15, 2024 at 3pm CST.**

Is a transcript required?

Yes. All applicants are required to submit a transcript. Transcripts must display the student name, school name, grades and credit hours for each course, as well as the term in which each course was taken.
