Dr. Joseph J. Jacobs Global Scholarship Program **Answers to Frequently Asked Questions**

OVERVIEW OF THE PROGRAM:

The Dr. Joseph J. Jacobs Global Scholarship Program (the "Program") was created in 2009 and is sponsored by the Jacobs Collectively Global Oversight Committee as a tribute to Dr. Joseph J. Jacobs (the founder of Jacobs Engineering Group Inc.) for his commitment and goal to make higher education affordable for children who seek it.

The Program is available to dependent children of employees (Vice President and below) of Jacobs Engineering Group Inc. and all of its subsidiaries (hereinafter, "the Company"). It seeks to encourage recipients to further their education in any of the science, technology, engineering, art, mathematics (STEAM), finance, legal, IT or human resources fields of study at any accredited college or university (or the international equivalent), to honor them for their achievements, and to assist them in financing that education.

The Program is independently administered by *SCHOLARSHIP AMERICA, a national nonprofit educational support and student aid service organization located in the United States. Awards are made on the basis of academic merit and the potential to succeed.

1. WHO CAN APPLY?

Applicants must be a Dependent Child with at least one parent who is an employee (Vice President and below) of Jacobs. The employee must have completed at least one year of continuous service as of the application deadline date and be actively employed by Jacobs on the date the scholarship is initially awarded (i.e., the date posted on the applicant's official notification letter from *SCHOLARSHIP AMERICA).

The applicant must be:

- a) a graduating student of a high school, secondary school, or similar institution (or equivalent, such as a GED);
- b) a graduate of a high school, secondary school, or similar institution; or
- c) a postsecondary undergraduate currently enrolled or planning to enroll in a full time course of study for the upcoming academic year at a four year accredited college or university or the international equivalent located in any country.

Four-year Accredited College or University or the international equivalents curriculum relevant to the Jacobs business are to be approved by the Jacobs Collectively Global Oversight Committee.

Lastly, the applicant must major in any of the science, technology, engineering, art, mathematics (STEAM), finance, legal, IT, or human resources fields of study.

Note: In no case may a dependent of a member of the Jacobs Collectively Global Oversight Committee be eligible to receive or renew a scholarship award.

2. WHO IS A DEPENDENT CHILD?

A Dependent Child is a person who is under 25 years of age, not regularly employed on a full-time basis and primarily dependent upon a parent employed by Jacobs for support and maintenance (i.e., with the employee providing at least 50% of the Dependent Child's overall support and maintenance). Dependent Children include any of the following: a natural child or grandchild, stepchild or step-grandchild, child or grandchild of a domestic partner, legally adopted child or grandchild, child, or grandchild for whom legal guardianship has been awarded to an employee of Jacobs or the spouse/domestic partner of an employee of Jacobs. A Dependent Child does not include anyone who is also a Jacobs' employee unless that employee is <u>not</u> benefits eligible.

3. WHO IS A FULL-TIME STUDENT?

A Dependent Child is a full-time student in the United States if they are enrolled in a four-year accredited college or university or the international equivalent taking at least 12 credit hours per term and pursuing an undergraduate degree. Outside of the United States, *SCHOLARSHIP AMERICA will rely on the college or university's definition of a full-time student. Any student must be enrolled in a four-year accredited college or university or the international equivalent for the entire academic school year.

4. WHAT COLLEGE OR UNIVERSITY CAN I ATTEND?

An applicant may apply to and attend any four-year accredited college or university or the international equivalent. By accredited, we mean any educational institution that is recognized by the applicable accreditation organization or government.

Accreditation ensures a basic level of quality in the education received from an institution. It also ensures the degree(s) will be recognized for the true achievements they are. It is the job of an accreditation organization to review colleges, universities, and other institutions of higher education to guarantee quality and improvement efforts. In the United States, accreditation organizations are private and not affiliated with the



government, though the government uses accreditation organizations to maintain the standards of the nation's colleges and universities. Accreditation organizations exist to review colleges, universities, and other institutions of higher education for standards of quality and improvement efforts. In most countries other than the United States, the government is responsible for accreditation.

If an applicant is not sure what college or university they will attend, the applicant should indicate their first school choice on the application. The applicant may change the college or university at a later date. *SCHOLARSHIP AMERICA will verify that the final college or university meets the requirements of this program. If the school fails to meet the Program requirements, the applicant must forfeit the award and may reapply the following year, if eligible.

5. WHAT MAJORS ARE ELIGIBLE FOR THIS SCHOLARSHIP?

Major in any of the science, technology, engineering, art, mathematics (STEAM), finance, legal, IT, or human resources fields of study.

6. HOW AND WHEN DO I APPLY?

To submit an application, please follow these steps:

- 1) Read this entire document and the related Jacobs Global Policy JJ-EB-PL-6014-JJ, *Dr. Joseph J. Jacobs Global Scholarship Program*, to be sure that the applicant is eligible to apply and has all of the information necessary to submit a completed application.
- Go to <u>https://learnmore.scholarsapply.org/jacobs</u> and complete the application online and upload any required documents. The applicant and employee (parent or grandparent) must electronically sign and date the application.

7. DO I HAVE TO COMPLETE THE APPLICATION IN ENGLISH?

Yes. We are not currently able to provide or accept applications in other languages.

8. WHAT DO I NEED TO SUBMIT WITH MY APPLICATION?

Please refer to the policy JJ-EB-PL-6014-JJ, *Dr. Joseph J. Jacobs Global Scholarship Program* for details of what needs to be submitted with the application. The following details some difference for non-US and US applicants.

- Non-US Applicants Only: Provide clear photocopies of the following educational documents from the past four years:
 - Transcript of grades or the international equivalent (academic record) Transcripts must display student name, grade and credit hours earned for each course and the term in which each course was taken.
 - 2) Secondary school credential/diploma/certificate if earned.
 - 3) Results of examinations.
 - 4) Academic records from different countries will be converted to a common grading scale for evaluation and comparison.

English translations must be provided for all non-English documents.



• US Applicants Only:

- Students currently or previously enrolled in college or vocational-technical school for at least one full <u>quarter or semester</u> must include all college or vocational-technical transcripts of grades from each school attended. On-line transcripts must display the student name, school name, grade and credit hours earned for each course and the term in which each course was taken. (Completion of high school information below is not necessary)
- 2) <u>High school seniors and students who have completed less than one full quarter or semester of postsecondary education</u> must include a high school transcript or grades and have the academic section of the application completed by the appropriate school official. (A clear explanation of the school's grading scale must also be submitted)

9. WHERE DO I SEND MY APPLICATION?

The application and academic documents must be submitted online, https://learnmore.scholarsapply.org/jacobs.

Carefully review the application before submission and print a copy of the application for your records. Applications are evaluated on the information supplied, so please answer all questions as completely as possible. Once an application is submitted, it may not be revised or supplemented. All applications are considered confidential and are reviewed only by [®]SCHOLARSHIP AMERICA. Late submissions and incomplete application packages will not be considered.

10. HOW MUCH IS THE SCHOLARSHIP?

Scholarship awards will range up to an annual maximum of \$3,000 (USD) (or the local economic equivalent) and will be paid in the local currency

11. HOW MANY SCHOLARSHIPS MAY BE AWARDED EACH YEAR?

Up to 20 new scholarships per year may be awarded and are allocated geographically to ensure inclusivity of the recipients.

12. ARE THE SCHOLARSHIPS RENEWABLE?

Yes. Scholarship awards may be renewed for up to three (additional) years or until an undergraduate degree is awarded, whichever comes first. To continue eligibility for the scholarship award after the initial award, a student must maintain a satisfactory academic record of at least a 3.0 grade point average a 4.0 scale (or the local equivalent) in a full time curriculum in one of the enumerate fields of study determined by the Jacobs Collectively Global Oversight Committee. There is no guarantee of renewal of an award, and all awards are contingent upon continuation of the Program by Jacobs.

13. HOW ARE RECIPIENTS SELECTED?

Selections for scholarship recipients are based on information contained in the applications and accompanying documentation. Each applicant's academic records, leadership positions, school and community activities, work experience, and a personal narrative describing career and educational aspirations and goals are considered.

In no instance does Jacobs or the Jacobs Collectively Global Oversight Committee participate in the selection process except to verify eligibility. Neither Jacobs nor the Jacobs Collectively Global Oversight Committee may add any scholarship recipients to those selected; however, they may remove a recommended recipient at the time of employment verification (an employee must have been employed for one year continuously in order for the dependent to be eligible for a scholarship). Proposed recipients may be removed and replaced if the



employee has not been continuously employed for that length of time). All applicants will be notified of outcome in writing by [®]SCHOLARSHIP AMERICA in July.

14. ARE ALL APPLICANTS GUARANTEED A SCHOLARSHIP?

The Global Scholarship Program is a competitive program; not all applicants will be recipients.

15. HOW ARE AWARDS PAID?

In the United States, ^{*}SCHOLARSHIP AMERICA will pay the award in a single lump sum as administratively practicable, with checks made payable to the accredited college or university but mailed to the recipient's permanent home address.

Recipients outside the United States may request payment of the full award to their bank account via a wire transfer. Notification letters informing recipients of their status will include a form requesting the recipient's bank information. Extenuating circumstances affecting an award payment must be communicated in writing to ^{*}SCHOLARSHIP AMERICA.

Each recipient is responsible for any taxes that may be imposed on the scholarship award.

16. WHAT CAN I USE THE SCHOLARSHIP FOR?

The scholarship can be used to pay for tuition, room and board, fees, books, and supplies for undergraduate level studies at the specific college or university. Applicants who receive other scholarships, grants or educational awards that fund their tuition, room and board fees, books, and supplies, can still use this scholarship to the extent you have qualifying expenses remaining.

17. CAN I USE THE SCHOLARSHIP FOR GRADUATE LEVEL STUDIES?

No. All awards are for undergraduate study only.

18. IF I DON'T RECEIVE A SCHOLARSHIP THIS TIME, MAY I APPLY AGAIN NEXT YEAR?

Yes. Applicants may continue to apply for a scholarship as long as they continue to meet the eligibility requirements.

19. WHAT ONGOING OBLIGATIONS DO EMPLOYEES AND/OR RECIPIENTS HAVE?

Scholarship recipients and their parents or grandparents have no obligation of any kind to Jacobs or the Jacobs Collectively Global Oversight Committee except as described in the Program guidelines (see Question 12), such as the following:

- Maintain full-time student status.
- Attend a four-year "accredited" college or university or the international equivalent.
- Continue to pursue an undergraduate degree in a science, technology, engineering, art, mathematics (STEAM), finance, legal, IT, or human resources field of study.
- Send a complete transcript and proof of enrollment when requested.
- Maintain the minimum academic requirements for scholarship renewals.

[®]SCHOLARSHIP AMERICA should be notified of any exceptions to the above and any changes in contact information (addresses, phone numbers, email addresses), or other relevant information.
